COVID-19 Vaccine Information

How do I get a vaccine?

In the state of Texas, everyone age 16 and older is now eligible for a COVID-19 vaccine. You do not have to be part of a special age group or have an existing health condition. Texas is one of the first states to make vaccines widely available for all adults.

You can get a vaccine in several ways:

- Visit the <u>Baylor Scott & White Health website</u> and sign up for a vaccine through the MyBSWHealth member portal or by calling 844.BSW.VACC
- <u>Go to the website for Texas Health and Human Services</u> and see options for vaccination hubs, retail pharmacies and community vaccine providers across Texas
- Register for the Texas Public Health Vaccine Scheduler (TPHVS) and use the statewide system for making a vaccine appointment

Are the vaccines safe? Do they work?

Nothing is more important than the health and safety of our communities.

On April 24, the Centers for Disease Control and Prevention (CDC) and the Food and Drug Administration recommended resuming use of the Johnson & Johnson/ Janssen COVID-19 vaccine for persons 18 years of age and older in the U.S., reaffirming its safety after a brief pause.

Following a thorough review of the data surrounding the small group of individuals who reported a rare and severe type of blood clot, the CDC, FDA and Advisory Committee on Immunization Practices (ACIP) **overwhelmingly agreed that the benefits of the vaccine far outweigh the risks**. However, based on guidance from the CDC and FDA, women under the age of 50 should be aware of this rare adverse event and know that there are other COVID-19 vaccine options available for which this risk has not been seen.

According to the CDC, <u>COVID-19 vaccines are safe and effective</u>. They recommend you get a vaccine "as soon as you are eligible."
